

WEBSITE PRIVACY POLICY

Unmanned Systems, Inc. dba. Albers Aerospace (“Company”, “we” or “us”) respects your privacy and is committed to protecting it through our compliance with this policy.

Please read this policy carefully before using Albers TacSight. By accessing or using Albers TacSight, you agree to this privacy policy.

1. Scope of Policy

This policy applies to information we collect through Albers TacSight, and in e-mail, text, and other electronic messages between you and Company. It does not apply to information collected by us offline or through any other means, including on any other website operated by Company or any third party, or by any third party, including through any application or content (including advertising) that may link to or be accessible from Albers TacSight.

2. Information We Collect and How We Collect It

We collect several types of information from and about users of Albers TacSight, including information:

- a) By which you may be personally identified. Examples include but are not limited to your name, phone number, address, and social security number, or e-mail address (“personal information”).
- b) That is about you but individually does not identify you, such as an e-mail address or other information required to use certain features, automatically recorded times and dates of visits to Albers TacSight.
- c) About your Internet connection, the equipment you use to access Albers TacSight and usage details.

We collect this information:

- a) Directly from you when you provide it to us, when you fill out a form, when you correspond with us, and when you respond to requests for comments on your experiences with Albers TacSight or to surveys that we might ask you to complete for research purposes.
- b) Automatically as you navigate through Albers TacSight. Information collected automatically may include usage details, traffic and location data, IP addresses and information collected through cookies and other tracking technologies.

The information we collect automatically is statistical data and does not generally include personal information, but we may maintain it or associate it with personal information we collect from other sources, information we receive from you or information we receive from third parties. It helps us to improve Albers TacSight and to deliver a better and more personalized service, including by enabling us to estimate our audience size and usage patterns, store information about your preferences, speed up your usage, and recognize you when you return to Albers TacSight.

3. How We Use Your Information

Information we collect may be used to process transactions, to send periodic e-mails, to improve our Albers TacSight, to personalize your experience, to improve customer service, and/or to administer a contest, promotion, survey or other feature.

4. Disclosure of Your Information

We will never sell your personally identifiable information without your consent. We do retain the right to disclose aggregated information about our users, and information that does not personally identify any individual, without restriction. We may also disclose your personal information: to comply with any court order, law or legal process, including responding to any government or regulatory request; to enforce or apply our Terms of Service and other agreements, including for billing and collection purpose; or if we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the Company, our customers or others. This includes exchanging information with other companies and organizations for the purposes of integrity protection, fraud protection and credit risk reduction.

5. Protection of Information

We have implemented a variety of measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration and disclosure. Encryption protects personal information you send when you transmit information or fill in forms through our Albers TacSight. SSL is the leading security protocol for data transfer on the Internet and helps to protect the safety and confidentiality of your information. Personal information, except for your name and email address, will not be stored on our servers.

Unfortunately, the transmission of information via the Internet is not completely secure. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to us. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained on the Albers TacSight.
